## <u>REASONS FOR JUDGMENT OF THE COURT</u> (Delivered from the bench at Quebec City, Quebec, on May 1, 2017.)

### NADON J.A.

- [1] Despite the very able presentation by counsel for the appellants, we are of the view that our intervention is not warranted. More specifically, we were not satisfied that the judge had committed an error in law or a palpable and overriding error in assessing the relevant facts.
