#### **REASONS FOR ORDER**

#### NADON J.A.

- [1] The appellant company seeks an Order allowing it, pursuant to Rule 120 of the *Federal Courts Rules*, to be represented by an officer, partner or member as the case may be.
- [2] Unfortunately, there is no basis for me to grant such a motion.
- [3] This Court's case law is clear to the effect that in order to succeed under Rule 120 a corporation must, *inter alia*, demonstrate that it cannot afford to pay for a lawyer. (See our decisions in *El Mocambo Rocks Inc. v. Society of Composers, Authors and Music Publishers of Canada* (SOCAN), 2012 FCA 98 at para. 3; S. A.R. Group Relocation Inc. and Susan A. Ryan Real Estate
